- I. ENGINE "Engineering curricula modernization in renewable energy in Albanian Universities", Ref. No. 619338-EPP-1-2020-1-AL-EPPKA2-CBHE-JP is a project cofunded by the Erasmus+ Programme of the European Union and led by Polytechnic University bringing together 11 partners (as above listed).
